# INTENSIVE CLEANER ECO/21



CLEAN & RESTORE

## Driveway & patio cleaner.

For cleaning all types of paving.

Removes ground in dirt and grime, detritus and tannin stains left by fallen leaves. Ideal for porcelain, sandstone, limestone, slate, granite, brick, terracotta, and concrete paving.

## DIRECTIONS FOR USE

**Important:** Test on an inconspicuous area before general application. Mask and protect painted surfaces, untreated wood, and other sensitive areas. Any alkalinity/product remaining on surfaces should be rinsed off. This may be done with clean water.

### SHAKE WELL BEFORE USE.

**In mild cases and on absorbent tiles:** Dilute 1:10 parts warm water. Apply with light pressure sprayer or scrubbing brush. Agitate the surface using a deck brush or scrubbing brush. Rinse by hosing off thoroughly with clean water.

**In more severe cases:** Dilute 1:3 parts warm water. Apply liberally using a light pressure sprayer or spreading over surface with a deck brush. Leave for 5-10 minutes and then agitate the surface using a deck brush or scrubbing brush. Rinse by hosing off thoroughly with clean water.

**In extremely severe cases:** Apply undiluted, add a little water, and agitate with scrubbing brush or deck brush. Leave for 10-15 minutes and then agitate the surface using a scrubbing brush or deck brush. Rinse by hosing off thoroughly with clean water.

In all cases on larger areas mechanical scrubbers can also be used. Do not use when surface temperatures are under 5°C or over 25°C.

## COVERAGE: PER LITRE

In mild cases - approximately 50m<sup>2</sup>

In more severe cases - approximately 20 m<sup>2</sup>

In extremely severe cases - approximately 5-10m<sup>2</sup>

## STORAGE INFORMATION

Store in a cool, dry, frost-free environment in closed container. Shelf life up to 5 years. Once opened use within 6 months of purchase for optimum results.

## NOTES

Cleaned patios that have been previously sealed should be re-sealed after using this product. This should be done after rinsing with plenty of clean water and once surfaces have had sufficient time to thoroughly dry (min 24hrs).
